



**Request of the expression of interest  
for Individual Consultancy services**

The TB Europe Coalition ("TBEC"), non-profit foundation registered in the Netherlands, announced call for expression of interest **to develop framework for the roadmap on cooperation between National TB programs, health providers and civil society in the EECA region of the TB-REP2.0 project** in the framework of the implementation of the current tasks of the Global Fund Multi-Country Program "Advancing People-Centered Quality TB Care – From the New Model of Care Towards Improving DR-TB Early Detection and Treatment Outcomes" (TB-REP 2.0).

**Scope of services:**

Individual consultant will be expected to:

1. In cooperation with the TBEC secretariat:
  - Develop the framework roadmap to be applied in specific countries of the EECA region.
  - The framework roadmap should be informed by the epidemiological, political situation of the East Europe and Central Asia region and be in line with existing recommendations for the region such as of WHO and Stop TB Partnership.
  - Develop the template of the MoU or joint statement between NTPs and civil society.

**Duration of Services:**

- The services are expected to be performed till December 31, 2019, with the possibility of continuation for the next TB-REP2.0 implementation periods.

**Conditions:**

1. You are invited to submit your expression of interest for the consultancy services mentioned above.
2. TBEC offers the following type of cooperation:
  - Consultancy Agreement with an Individual Consultant/Expert
3. The contract will be awarded on the competitive basis to Consultant/Expert with the highest qualifications and that meet all requirements described on Terms of References (ToR<sup>1</sup>). Consultant will be evaluated based on the qualifications, consultancy fee will be negotiated based on the consultant's expertise evaluation results.
4. Your expression of interest should contain the following documents that must describe your experience and qualification according to requirements described on ToR.
  - CV
  - Covering letter
  - Letters of recommendation will be considered an asset
